Dear Supplier,

As you are aware there have been several EU RASFF alerts concerning sesame seed being contaminated with an unauthorised substance 'ethylene oxide' (ETO).

Ecotone (formally known as Wessanen) has already been in contact with its suppliers asking if the products supplied to Ecotone were affected by this issue and action has been taken where necessary.

Ecotone has now been made aware that there are a number of additional raw materials that may be potentially affected by the same issue as sesame. It is also understood that it is common practice in certain parts of the world to fumigate containers at ports prior to shipping. It is therefore critical that suppliers of organic products ensure the integrity of the organic supply chain.

Ecotone has therefore, carried out a review and according to its own risk assessment the following raw materials are also deemed to be at ETO risk (see below); however, it has to be noted that the list is <u>not exhaustive</u> and therefore suppliers are asked to highlight any emerging risk to Ecotone.

Raw materials at ETO Risk: Pepper, Thyme, Parsley, Amaranth, Nuts, Seeds, Rice, Turmeric, Psyllium, Ginger, Chillies, Tea, Okra, Shallot, Dried mushrooms, Dried vegetables, Guar Gum, Spices, Lecithin.

Ecotone is asking for assurance that the products that you supply to us are not affected by this issue and we ask you to perform testing to prove compliance to applicable EU regulations of any <u>new</u> raw material consignment that will be used in the manufacture of our products.

We hold all our suppliers responsible for the safety and integrity of the products made on our behalf; we therefore consider our supplier liable in case of issues being identified.

We also trust that you will be upholding the highest food safety and quality standards; Ecotone would appreciate if you were to return the signed statement by the 30<sup>th</sup> of April 2021.

If however, we do not hear back from you by the 30<sup>th</sup> of April 2021, we will consider that this is confirmation that all is compliant.

Thank you very much for continuing to maintain the quality of the products you supply to us.

We thank you in advance for your co-operation with this important matter.
